

United Way Fox Cities Official Rules for 2025 Kia K4 LXS FWD Sweepstakes

Sponsored by United Way Fox Cities (the "Sponsor"), 1455 Midway Road, Menasha, WI 54952. NO DONATION NECESSARY. VOID WHERE PROHIBITED. DONATION WILL NOT IMPROVE CHANCES OF WINNING.

- 1. This incentive promotion begins on April 1, 2025, and ends at 4:30 p.m. Central Time on December 12, 2025. Entrants must be legal residents of Wisconsin, at least 18 years of age, and possess a valid Wisconsin driver's license at time of entry.
- 2. The winner will receive a 2025 Kia K4 LXS FWD from United Way Fox Cities. Odds of winning depend on the number of eligible entries received.
- Any United Way Fox Cities donor that timely gives a new, undesignated gift of \$1.00 per week (\$52 a year) or more – or maintains their prior year gift of at least \$1.00 per week (\$52 a year) – will be eligible for one entry into the sweepstakes.
